C24/200 Apologies for Absence

C24/202 Community Police

A report was received from the police.

C24/203 Public Participation

A member of the public spoke about the provision of emergency planning in Whaley Bridge. They are a local community volunteer who has just undertaken the Community's prepared training on emergency planning and is also a local flood warden. They commented that there was redacted emergency planning information released around the Toddbrook Incident in 2019 but these plans have subsequently disappeared. To find the contact details for the Derbyshire resilience partnership you had to find it via the government website and the information in unavailable on the Derbyshire County Council website. They continued to comment that DCC and HPBC have made a statement about the emergency plan saying that the plans are unavailable as they contain personal details of officers required in major incidents.

The resident questioned why redacted versions of the plans are not available as the Government stated in its Preparation for planning for Emergencies that it is not necessary to publish the whole plan and personal contact details can be left out. Finally he stated that the statutory responders have a duty to maintain plans and that local voluntary and community groups should be considered as part of emergency responses. They asked the Town Council if we would consider pressuring DCC to release this information and to add local volunteers to the emergency plans where necessary.

RESOLVED: The Clerk will contact the responsible officer at DCC stating the experience locally from the Toddbrook incident showed how essential it was to have community knowledge. The Council are aware DCC have an emergency

plan and would like to work with DCC to establish a local contact list to be appendix to the plan and reviewed annually.

RESOLVED: The Clerk will also contact DALC to ask for some advice and the Council will review the situation once we hear back from DCC.
